WHAT IS A HEALTH CARE DIRECTIVE?

A health care directive is a document that enables you to make decisions now about your medical care in the future. It offers guidance to your family and doctors when you cannot speak for yourself.

CAN HEALTH CARE DECISIONS BE MADE FOR ME WITHOUT A DIRECTIVE IN PLACE?

Yes. If you have not completed a health care directive and are unable to make decisions, family members and close friends could make health care decisions for you. However, it is best that they understand your wishes and values.

WHERE CAN I GET INFORMATION AND A HEALTH CARE DIRECTIVE FORM TO COMPLETE?

3. Your Foster Care Caseworker or Independent Living Coordinator

TO BE LEGALLY RECOGNIZED IN NORTH DAKOTA, A HEALTH CARE DIRECTIVE MUST:

1. Be in writing and be dated
2. State your name
3. Completed by you with your signature
4. Contain proof of your signature and the signature of the person you authorize to make decisions on your behalf if you are unable to do so. (A notary or two witnesses)
5. Include health care instructions



IS THERE ANYONE I CANNOT APPOINT TO MAKE HEALTH CARE DECISIONS FOR ME?

You cannot appoint your health care provider, long-term care provider, or a non-relative employee of these providers.

WHAT DO I DO WITH MY COMPLETED HEALTH CARE DIRECTIVE FORM?

Get it notarized (may require a small fee). Make copies. Keep a copy and provide copies to those you have appointed to make decisions on your behalf. Provide a copy to your health care provider for your medical record. It is a good idea to make a wallet card stating you have a health care directive in place.
