1915(i) Eligibility Criteria The SFN 741 1915(i) Eligibility Application serves as the official request for 1915(i) eligibility determination. The Zone must complete the eligibility determination no later than five (5) business days after receiving the completed application.

An applicant is eligible for the 1915(i) if <u>all</u> of the following criteria are met:

- Age 0+
- Recipient of Traditional Medicaid or Medicaid Expansion
- Federal Poverty Level is at or below 150% (Federal Poverty Level)
- Has a qualified 1915(i) Behavioral Health diagnosis (Diagnosis List)
- Has a complex score of 25 or higher on the WHODAS 2.0 assessment; or a score of 5 or lower on the DLA
- Does not reside in an institution

At any point a member doesn't meet one of the eligibility criteria, they are not eligible for the 1915(i).

SPACES COE Codes Identifying Traditional and Expansion Coverage

The SPACES COE codes below are to help identify if a member has Traditional or Expansion coverage. Utilize the chart below determine if a member has chosen to be served under Traditional Medicaid or Medicaid Expansion and input their Traditional or Expansion eligibility dates into the 1915(i) Web System under the appropriate section.

- The red asterisks are all required fields and if not filled in, you'll receive an error message.
 - If "Translator Needed" is "Yes", the "Language" field must be filled in.
 - "Date of Birth" requires a four (4) digit year.
 - "Age" field will auto-populate
 - Leave "Is on Medicaid?" box selected for members who have a Medicaid ID number
 - Unselect the "Is on Medicaid?" box (see below) if an applicant has never been on Medicaid in their lifetime and has no Medicaid ID number.



Approval of Eligibility

Enter the following information into the system if 1915(i) eligibility is approved:

- 1. Create a new member or search for an existing member following the steps above.
- 2. Enter start/end dates for either Traditional Medicaid or Medicaid Expansion, whichever is applicable. Note: Have to click "Save" before system allows Medicaid dates to be entered.
 - Must be Medicaid eligible for 1915(i) eligibility.
 - Medicaid start/end dates are identified in SPACES.
 - Click "+ New Traditional Medicaid" or "+ New Medicaid Expansion" tab, whichever is applicable.
 Dates require a four (4) digit year.
 - If no Medicaid "End Date", enter "12/31/9999".
 - Click "Save & Close".
- 3. Federal Poverty Level at or Below 150%
 - Must be at 150% or below for 1915(i) eligibility.
 - Assess poverty level from the applicant's income in SPACES utilizing the 1915(i) FPL Table -Federal Poverty Level.
- 4. Diagnosis
 - Must have a 1915(i) qualifying diagnosis for 1915(i) eligibility <u>Diagnosis List</u>.
 - Diagnosis is found on the eligibility application.
 - Click "+ New Diagnosis" in the "Active Diagnosis" section.
 - "Status" Primary, Secondary, Tertiary options
 - Enter in the order as identified on the eligibility application.
 - "Diagnosis Code" type in code or click magnifying glass and scroll to find the diagnosis.
 - "Diagnosis Date" is found on eligibility application. If one isn't provided, leave field blank.
 Date requires a four (4) digit year.
 - Click "Save & Close".
 - Repeat the process for secondary and tertiary diagnoses, if applicable.
- 5. WHODAS or DLA overall score (only one is required)
 - Overall WHODAS assessment score must be at 25 or higher for 1915(i) eligibility.
 - Overall DLA score must be 5 or lower for 1915(i) eligibility
 - The score is found on the eligibility application.
 - If no score, perform a WHODAS assessment <u>only</u> if all other eligibility criteria is met.
- 6. "Member's Rights" is checked "Yes" after applicant is informed of their rights, appeals and hearing options, and choice of service providers by providing this form <u>Member Rights and Responsibilities</u>.
- 7. Client "Status" is updated to "Approved" <u>only</u> if all eligibility criteria is met.
- 8. "1915(i) Eligibility Dates" are entered.
 - Dates require a four (4) digit year.
 - See 1915(i) Eligibility Start and End Date sections in the Eligibility Policy.
- 9. Click "Save".
- 10. Upload the SFN 741 1915(i) Eligibility Application, and WHODAS assessment and WHODAS score sheet or DLA into Filenet using Shortname 88.
- 11. Send the following to the applicant:
 - 1. Approval letter informing the applicant they are required to report income over 150% FPL throughout the eligibility period.
 - Click "Word Templates" on the toolbar (see below).

- 2. 1915(i) Fact Sheet for Individuals Deemed Eligible Fact Sheet for Individuals Deemed Eligible.

Denial of Eligibility

At any point an applicant does not meet one of the 1915(i) eligibility criteria, they are not eligible. If the applicant is not Medicaid eligible or does not have a qualifying diagnosis, there is no need to access the Federal Poverty Level (FPL) or WHODAS as the applicant is ineligible. If the applicant doesn't meet the FPL, there is no need to access the WHODAS.

*Note, no changes can be made to an application once "Denied" status is selected or saved.

• Select "Pending" status to make changes.

Enter the following information into the system if 1915(i) eligibility is denied:

- 1. Create a new member or search for an existing member following the steps above.
- 2. Enter start/end dates for either Traditional Medicaid or Medicaid Expansion, whichever is applicable. <u>Note: Have to click "Save" before system allows Medicaid dates to be entered.</u>
 - Medicaid start/end dates are identified in SPACES.
 - If applicant is <u>not</u> Medicaid eligible, leave start/end dates blank.
 - Click "+ New Traditional Medicaid" or "+ New Medicaid Expansion" tab, whichever is applicable.
 - Dates require a four (4) digit year.
 - If no Medicaid "End Date", enter "12/31/9999".
 - Click "Save & Close".
- 3. Federal Poverty Level at or Below 150%
 - If applicant is not Medicaid eligible, do not assess poverty level and select "Undetermined".
 - If applicant is Medicaid eligible, assess poverty level from the applicant's income in SPACES utilizing the 1915(i) FPL Table <u>Federal Poverty Level</u>.
 - Select "Yes" or "No" depending on assessment result.
- 4. Diagnosis
 - Must have a 1915(i) qualifying diagnosis for 1915(i) eligibility Diagnosis List.
 - Diagnosis is found on the eligibility application.
 - Click "+ New Diagnosis" in the "Active Diagnosis" section.
 - If no qualifying diagnosis, select "no qualifying diagnosis", click "Save & Close", and move on to Step 5.
 - "Status" Primary, Secondary, Tertiary options
 - Enter in the order as identified on the eligibility application.
 - "Diagnosis Code" type in code or click magnifying glass and scroll to find the diagnosis.
 - "Diagnosis Date" is found on eligibility application. If one isn't provided, leave field blank.
 Date requires a four (4) digit year.
 - Click "Save & Close".
 - Repeat the process for secondary and tertiary diagnoses, if applicable.
- 5. WHODAS or DLA overall score (only one is required)
 - This score is found on the eligibility application.
 - If no score, <u>only</u> perform a WHODAS assessment if <u>all</u> other eligibility criteria is met.
 If all other eligibility criteria is not met, do not perform WHODAS and enter "0".
- 6. "Member's Rights" is checked "Yes" after applicant is informed of their rights, appeals and hearing options, and choice of service providers by providing this form <u>Member Rights and Responsibilities</u>.
- 7. Client "Status" is updated to "Denied" with the appropriate reason(s) selected from the drop-down menu.
- 8. Click "Save".
- 9. Upload the SFN 741 1915(i) Eligibility Application, and WHODAS assessment and WHODAS score sheet (if assessed) or DLA into Filenet using Shortname 88.
- 10. Send the following to the applicant:
 - 1. Denial letter
 - Click "Word Templates" on the toolbar (see below).

- Click "Enable Editing" at the top of the letter.
- Manually enter [Zone Contact Information] in template.
- Print and mail letter to member.
- Save letter as PDF and upload into Filenet using Shortname 88 with the description Denial Letter.

Suspension of Eligibility

When an eligible individual enters a non-compliant HCBS setting for 6 months or less, eligibility will be suspended, not closed. Closure will occur when an individual is placed in a non-compliant setting for 6 months or more or whenever their eligibility expires, whichever occurs first.

The Zone will change the case status to suspended in the 1915(i) Web System and back to approved upon the individual's discharge. The 1915(i) eligibility dates will remain in the system.

To suspend 1915(i) eligibility for an existing member, follow the steps above for "Search for an Existing Application for an Existing Member". Click the "Application ID" for the "Approved" application and update the following:

- 1. Client "Status" is updated to "Suspended".
- 2. Add any relevant notes.
- 3. Click "Save".

Closure of Eligibility

At any time one of the 1915(i) eligibility criteria is not met after an applicant has been determined eligible, their eligibility must be closed in the 1915(i) Web System.

*Note, no changes can be made to an application once "Closed" status is selected or saved.

• Select "Pending" status to make changes.

The 1915(i) Web System automatically closes a case when 1915(i) eligibility has expired. If a case was automatically closed due to expiration, an eligibility closure letter will be generated and sent by the State.

To close 1915(i) eligibility for an existing member, follow the steps above for "Search for an Existing Application for an Existing Member". Click the "Application ID" for the "Approved" application and update the following:

- 1. Only update the current "Traditional Medicaid End Date" or "Medicaid Expansion End Date" if closure is due to Medicaid ineligibility.
 - Use the date Medicaid ended in SPACES for the "Traditional Medicaid End Date" or "Medicaid Expansion End Date".
 - Dates require a four (4) digit year.
- 2. Update any eligibility criteria that has changed and is not being met.
- Ex. FPL increased to over 150%, update the "Federal Poverty Level at or Below 150%" to "No". 3. Go to "1915(i) Eligibility Dates" section (see below).

Annual 1915(i) Eligibility Redetermination

A 1915(i) eligibility redetermination must be completed at least annually.

When an annual 1915(i) eligibility redetermination occurs, complete the following: "Create a New Application for an Existing Member" (steps identified above) and follow the instructions above depending on "Approval of Eligibility" or "Denial of Eligibility".

Note: Never create a new 1915(i) eligibility span in an existing application. Always create a new application.

Care Coordinator Request for Information

After the member has chosen their care coordination provider, the care coordinator will request eligibility related documents from the Human Service Zone. The Zone will receive a Request of Information from the care coordinator, upload it into the web-based system, and send the following to the care coordinator for plan of care development:

- 1. SFN 741 1915(i) Eligibility Application,

- WHODAS assessment and scoresheet, or DLA assessment
 1915(i) Eligibility Dates, and
 Whether the individual is on Traditional Medicaid or Medicaid Expansion.

Edit/Delete Eligibility Dates

To edit an eligibility date entry, follow the steps below:

Note: Eligibility dates can not be edited when an application is in "Denied" or "Closed" status.

To change Traditional Medicaid to Medicaid Expansion in the web system, follow the steps above for "Search for an Existing Application for an Existing Member". Click the "Application ID" for the "Approved" application and update the following:

1. Click the current eligibility in the "Traditional Medicaid Eligibility Dates" section. This will select the date range and an "Edit" button will appear (see below).

- 3. Update the "End Date" to the date Traditional Medicaid ended in SPACES.
 - Date requires a four (4) digit year.
- 4. Click "Save & Close".
- 5. Click "+ New <u>Medicaid Expansion</u> Date" in the "Medicaid Expansion Eligibility Dates" section.
 - Dates require a four (4) digit year.
 - "Start Date" is the date Medicaid Expansion started in SPACES.
