## **Opioid settlement updates**

Elin Alm from the Attorney General's office presented an update on the settlements. The settlement with CVS, Walgreens, and Walmart has been finalized. North Dakota could start seeing payments this year.

#### **Updates from the State Investment Board**

Amy Lies, Opioid Addiction Administrator, Behavioral Health Division, DHHS and Committee Administrator provided information regarding the investment of the opioid settlement funds. The funds are not currently being invested. By reaching out to the State Investment Board, the process to invest the funds has now begun. Amy will provide an update at the next meeting.

## ND Opioid Settlement Fund (OSF) Grant

Amy Lies, Opioid Addiction Administrator, Behavioral Health Division, DHHS and Committee Administrator provided information to the committee regarding the grant. The Behavioral Health Division (BHD) announced the OSF grant in November and received 65 applications for opioid settlement funds. BHD awarded 14 agencies. No further funding is available for the grant and therefore has been closed for any application submissions.
