## **Subdivision Allocation Plans**

N.D.C.C 50-36-06 states "A political subdivision that recovers moneys as a result of opioid litigation may deposit the moneys in the fund or may retain the moneys and transfer the moneys to the public health unit that provides services to that political subdivision" and that "All political subdivisions shall provide an allocation plan to the behavioral health division prior to expenditure."

- Since the last committee meeting, there have been 0 plans submitted
- Email communication was provided to all Local Public Health Units (LPHUs) about the submission of allocation plans
- BHD will update the committee regularly

### Opioid Settlement Advisory Committee

The State of North Dakota, through its Attorney General, has reached court-approved settlement with opioid manufacturers and distributors.

A requirement to receiving and spending settlement funds is the creation of an advisory committee. The Opioid Settlement Advisory Committee has been established through an executive order 🙆 issued by Gov. Doug Burgum and through North Dakota Century Code 50-36-06.

The Opioid Settlement Advisory Committee will provide input and recommendations to the North Dakota Department of Health and Human Services Behavioral Health Division regarding the spending of funds received by the settlement. The usage of settlement funds must be used for opioid remediation and align with approved usages as identified in the settlement document Exhibit E<sup>ad</sup>.

#### Political Subdivision Allocation Plans:

As required by North Dakota Century Code 50-36-06<sup>a</sup>, a political subdivision that recovers and retains moneys as a result of opioid litigation shall collaborate with a public health unit on the use of the moneys for local programs for remediating and abating the opioid crisis. All political subdivisions shall provide an allocation plan to the behavioral health division prior to expenditure.

# Recommendations from BHD

### BHD Priority Recommendations

Prevention – coalitions and community work

Opioid overdose reversal medication

Syringe Service Programs

Increase access to treatment – *medication for opioid use disorder* (MOUD) at Community Behavioral Health Clinics (HSCs) and local jails

Increase access to recovery housing that allows MOUD – *Recovery Housing Assistance Program (RHAP)* 

Tribal implementation – \$310,833 funding need

# **Grant Process - Regulation**

### **Opioid Settlement Advisory Committee**


• NDCC 50-36-03 (2) states "the committee shall forward recommendations to the department on spending decisions of the legislatively appropriated funds for remediation or abatement of the opioid crisis in this state"

### Procurement Laws

- NDCC 54-44.4 State Purchasing Practices
- NDAC 4-12-01-04 (1)(h) states "These rules apply to all procurements of commodities and services, regardless of the funding source, by each state agency and institution in the executive branch of government, except this chapter does not apply to Grant programs, not including procurements using grant dollars"

# **Grant Process – Contract Requirements**

- Vendor shall provide services in a manner that is recovery-oriented, trauma-informed, and personcentered
- Contracts may be terminated through mutual consent or upon 30-days written notice with or without cause
- Vendor shall utilize settlement funds as a payor of last resort
- Vendor shall ensure no duplication of funding
- Vendor shall comply with reporting deadlines
- Vendor shall ensure funds are used in a manner aligning with Exhibit E

> > Update the committee at routine intervals such as quarterly meetings
