

## 2023 Opioid Settlement Fund

**Budget Report** 

## **Background:**

During the 68<sup>th</sup> Legislative Assembly, HB 1447, later codified as NDCC 50-36, appropriated eight million dollars of the moneys in the opioid settlement fund to the ND Department of Health and Human Services (DHHS) each biennium. The funds are being administered by DHHS Behavioral Health Division (BHD). At least twenty percent of the funds must be used for opioid use prevention and overdose prevention, including best practices relating to fentanyl drug overdose, and approved use for workforce development.

A political subdivision that recovers moneys as a result of opioid litigation may deposit the moneys in the fund or may retain the moneys and transfer the moneys to the public health unit that provides services to that political subdivision. All political subdivisions shall provide an allocation plan to the behavioral health division prior to expenditure.

## Status of the Opioid settlement Fund and decisions made by the department:

In October 2023, BHD purchased 6,000 Narcan kits (a kit is 2-doses of nasal naloxone) utilizing federal State Opioid Response (SOR) grant funds. The Opioid Settlement Advisory Committee voted and approved \$636,380 of opioid settlement funds to be used for future purchases of Narcan at the 10/17/2023 committee meeting. It is anticipated the next Narcan purchase will occur in January 2024 and will be funded with opioid settlement funds.

Spirit Lake, Standing Rock, and Three Affiliated Tribes applied for SOR funding in October 2023. Unfortunately, their applications requested more funds than what were available. The Opioid Settlement Advisory Committee voted and approved the use of opioid settlement funds to fill the gap for those three tribes at the 10/17/2023 committee meeting.

BHD announced the Opioid Settlement Fund Grant on 11/20/2023. The first round of applications was due by 12/22/2023 and BHD announced awards on 1/19/2024.

## Political subdivision funding and allocation plans:

During 2023, subdivisions received \$225,078 bringing the total received by subdivisions to \$1,525,102.18. An allocation plan has been submitted for 19 subdivisions in partnership with their Local Public Health Unit.
