Cavalier County Health District Adult Binge Drinking Prevention Strategic Plan 2023-2026

Problem: Social norm of adult binge drinking in Cavalier County **Supporting Data:** Adults report high levels of binge drinking on the BRFSS and local data collection. Arrest data reflects higher rates of arrest for adult alcohol related offenses than for other substances or for youth offense. Local stakeholders report adult alcohol use results in the most problematic outcomes in their work. Local data self reporting shows adults in Cavalier County have little recognition of what constitutes binge drinking. Local stakeholders report having few events without alcohol and few alcohol restrictions at events with alcohol. Cavalier County has high alcohol outlet density compared to the state of ND and the US as a whole.

Goal 1: Decrease the % of Cavalier County residents reporting consuming 3 or more alcoholic beverages on the days they drank in the last 30 days on local data collection by 5% (from 30.67% in 2021 to 25.67% in 2026).

Objective 1: Pass local ordinances requiring RBS as a condition of liquor licensure to reduce adult binge drinking resulting from overserving.

Strategy 1.1: Partner with Cavalier County Sheriff Department to offer no cost RBS training to local liquor license holders.

Activity 1.1.a Create partnerships with Cavalier County Sheriff Department to offer RBS training.

barriers to RBS training and RBS ordinance.

Activity 1.5.a Meet with and assess level of decision maker support for RBS ordinance. Identify possible champions within elected bodies.

Goal 2: Decrease self-reported adult binge drinking on the BRFSS by 5% by 2026 (from 22.8% in 22022 to 17.8% in 2026).

Objective 2: Change the cultural norms surrounding binge drinking in Cavalier County from a norm of adult binge drinking to a norm of lower or no alcohol use.

Strategy 2.1: Conduct a communications campaign to increase recognition of what constitutes binge drinking.

Activity 2.1.a Locate and create a media campaign materials for print, radio, social media and billboards on what constitutes binge drinking.

Activity 2.3.a Identify alcohol free community events such as Chamber of Commerce Events, Northern Lights Arts Council Events, School events, fraternal organizations, faith based events through social media posts, websites, newsletters, direct outreach to organizations etc.
