#### **ORGANIZATION NAME: Dickey County Health District**

- a. Provide a narrative of the problem:
  - i. Underage drinking continues to be a problem in Dickey County. Youth ages, 14-20 are drinking alcohol in shops, stealing alcohol from their parents or guardians, or getting alcohol from older friends. Data has proven that Dickey County residents agree that underage drinking is a problem, but also believe that law enforcement needs to be enforced around this issue. My strategic plan lays out my goals in regard to how I will enforce prevention in our county.

### **Strategic Plan Outline:**

**Problem Statement:** There is a high occurrence of underage drinking among individuals ages 14-20 in Dickey County.

- 2021 YRBS Survey, 23.7% of students from Region IV reported that they currently had drank alcohol before.
- According to Region 6 WYSAC Survey of 2022, 26.4% reported that youth alcohol is a problem in their communities. 44% think it's a moderate problem and 30% of individuals think it's a serious problem.
- Substance Abuse Prevention Data 2023 (Dickey County), 84% of individuals reported underage drinking is an issue in Dickey County.
- 55.7% of youth reported that they have drank alcohol in their life, according to YRBS.
- 23.7% of ND high school students report current alcohol use (within the last 30 days.)
- In the last three years, there were 123 child protection service reports in Dickey County. All of these families had drug and/or alcohol involvement.
- From Crimestats, for Dickey County, in the last four years there have been 7 DUI arrests for ages 18-24, which also includes MIP.
- According to OVAS, 2021-2022 dispatch calls were 14 involving alcohol consumption. 5% of these were considered minors. It was also reported that many minors are taken into the hospital by personal vehicles due to confidentiality and small-town gossip.

Objective 1: Reduce alcohol use by young adults aged 14-20.



#### Goal 1: Reduce Underage Drinking in Ages 14-20.

Objective 1: By September  $30^{th}$ , 2026, decrease underage drinking use by young adults age 14-20 by 5%.

Strategy 1: Provide opportunities to educate youth on the dangers of underage drinking.

<u>Activity 1- Information Dissemination</u>: Host booths at community events with the purpose of reaching individuals on underage drinking, hang up posters/flyers in high traffic areas in the community, run radio messaging, tv ads, newsletters, and newspapers ads.
