## Agenda Items

#### Welcome and Call to Order

The meeting was called to order at 1:04 PM by Chairperson Melanie Gaebe. Roll call confirmed a quorum.

## **Approval of Previous Meeting Minutes**

- Motion to approve the January 2, 2025, meeting minutes was made by Megan Indvik and seconded by Richard Smith.
- Motion passed unanimously.

#### **Public Comment**

- Benjamin Schaffer, Executive Director of the Western Education Regional Cooperative, raised concerns about behavioral health resources for schools and presented a proposal for regional support for students prior to state placements.
- Chairperson Gaebe thanked Mr. Schaffer for his comments and directed him to existing resources, noting that some funding might not be applicable.

#### **Review of Legislative Calendar Activities**

#### Discussion:

- Chairperson Gaebe provided an overview of the legislative activities for the week, focusing on budget hearings and the behavioral health package in the Governor's budget proposal.
- Bills discussed included:
  - Senate Bill 2171: Modifications to emergency mental health petition procedures.

- Senate Bill 2200: Creation of a crisis stabilization fund supported by a communication services surcharge.
- House Bill 1337: Appropriation of \$10 million for mental health services for incarcerated individuals.
- Senate Bill 2190: Addition of applied behavioral analysis to Medicaid benefits

#### Actions:

- 1. Chairperson Gaebe and Tami Conrad will gather and disseminate comparisons between the current Governor's proposal and the previous administration's recommendations regarding behavioral health priorities when available.
- 2. Committee members were encouraged to monitor legislative schedules and provide updates on bills of interest.

# **Next Steps and Consideration of Action Items**

#### Discussion:

- The committee discussed the potential implications of Senate Bill 2096, which
  provides appropriations for state hospital renovations and regional psychiatric
  treatment.
- Questions were raised about whether the bill could conflict with support for a new state hospital. Chairperson Gaebe agreed to attend the hearing and provide clarification.
- Committee members emphasized the importance of balancing support for local and state-level behavioral health services.

## Actions:

- 1. Chairperson Gaebe will provide updates on SB 2096 after attending the hearing.
- 2. Paul Stroklund will reach out to key sponsors for further insights.
- Committee members were directed to review House Bill 1223, focusing on suspension and expulsion policies for K-12 students, for its potential behavioral health impact.
