INSTRUCTIONS FOR COMPLETEING FORMS AND SUBMITTING A FINGERPRINT-BASED CRIMINAL BACKGROUND CHECK.

Go to https://www.hhs.nd.gov/providers/criminal-background-checks/child-care-providers to access required forms.

- Complete Personal Authorization for Criminal History Record Information Inquiry Form (SFN 829).
 - o This form must be typed. Handwritten and/or incomplete forms will not be accepted.
 - The requesting agency will be the ND Department of Health and Huma Services.
 - Contact person, telephone number, and email address must be the Licensing Specialist that oversees the provider's license. Obtain this information from the provider.
 - Select Child Care.
 - Check Therapy Service Provider and enter the name of YOUR employer in the space after the colon.
 - Enter the information for one of the child care programs you will be entering to provide services.
 - Enter your information in the Applicant Information section.
 - YOUR personal email address is required
 - Do not leave any sections blank.
 - o Answer questions 1-3.
 - If you answer "yes" to questions 2 or 3, you <u>MUST</u> provide information in the box below the questions.
 - Address history you must provide a full 5-year address history.
 - Begin with your current <u>street address</u> and work backwards. If additional space is needed, please use SFN 829 – Page 2.
 - If you lived in another state in the past 5 years, you may need to complete additional authorization forms for out-of-state record requests.
 - Click on the folder for each state you have lived in during the past 5 years.
 - Read the form instructions BEFORE clicking on the form PDF.
 - Print the completed form BEFORE signing and dating the form. Some forms require notary or witness signatures.
 - All forms for other states must be mailed to the CBCU office in Bismarck.
 - o Sign, date and print the form. It can also be signed and dated after it has been printed.
- 2. Complete Criminal History Record Check Request Form (SFN 60688).
 - o This form **must be typed**. Handwritten forms will not be accepted.
 - o Do not change any information that has been pre-entered into the form.
- 3. Print a BLANK Fingerprint Identity Verification Form (SFN 836).
- 4. Schedule an appointment with the Human Service Center in your region to be fingerprinted. You <u>must</u> print and bring **ALL** forms and a valid government issued photo ID to your appointment.
 - You may also be fingerprinted at a law enforcement agency, or any other agency that is authorized to do fingerprinting, however, you must mail your forms and sealed fingerprints to:

Transfer Requests – Complete <u>AFTER</u> you have received final result memo.

- 1. Complete an SFN 356 Authorization to Transfer Background Check Results Early Childhood (Therapy Provider)
 - Name of Child Care Program or Licensed Provider will be the same as the provider you entered on your SFN 829 form.
 - Date of Separation enter Still Employed
 - o Enter each additional childcare program you will be entering to provider therapy services.
 - Date of Hire should be the date you are completing the form.
- 2. Your stamped SFN 356 form and a copy of your background check memo will be emailed to you via securemail.
 - You must provide each childcare program entered on the SFN 356 form with a printed copy of both documents to keep for their records.
