Home and Community Based (HCB) Setting Provider Survey Results

This document contains a list of questions used in the Provider Survey and the corresponding responses to determine compliance with the CMS new rules of HCB settings. Surveys were sent to all thirty-one DD licensed providers who provided HCB services to answer questions on each of their residential and non-residential waiver settings. The DD Division received a 100% return response from the Provider Survey. Data was received on 913 residential and non-residential settings, which is reflected in this document.

The questions were based on criterion provided in the CMS guidance and toolkit, focusing on location, characteristics that have the potential for isolating, and identifying settings that are presumed to have qualities of an institution.

DD Division reviewed each providers' responses to all survey questions about residential and non-residential settings, utilizing them for an initial determination of compliance. DD Division reached out to Providers and Regional Human Service Centers to obtain additional clarifying information where the responses were not clear, appeared incomplete, or inconsistent.

Subsequently, Navigant Consulting reviewed each provider's survey responses for each setting and written responses to DD Division follow-up questions. Navigant further refined the survey analysis by focusing on a subset of questions that best indicated whether each setting facilitated community integration or created an isolating environment. Some survey questions were not considered in the final analysis or were given lesser weight because the distribution of responses indicated that some providers interpreted the question differently than others, causing inconsistency in the data. For example, responses to the question about whether individuals without disabilities reside at the same location revealed that some providers responded with the client's apartment in mind while others responded with the entire building or neighborhood in mind.

Overall, based on the further information gathered (which also included reviewing plans) and in conjunction with the consumer surveys some non-compliant responses within the raw data collected, were later determined to be compliant indicating that in fact experiences and requirements were present.
